Objective

Responsibilities

- 1. Delivery of a comprehensive training outline.
- Development of training materials based on the available Methodology. Training should cover a multitude of topics that include but are not limited to, Green Business Plan Development and Impact Management, Eco-Design, Access to Finance, and Access to Market.
- 3. Preparation of a comprehensive practical homework plan for the entirety of the training and workshops.
- 4. Delivery of a 10-day capacity-building workshop to GIMED participants.







- 5. On-going assessment of workshop participants online, through their profiles on the platform, as well as offline;
- 6. Development and evaluation of individual business plans in collaboration with the GIMED Participants through online and offline tools and methods of support;
- 7. Participating in the selection of 20 out of 40 early-stage entrepreneurs to progress into the next phase of the project;
- 8. Provision of deliverables and documentation according to the project timeline to be provided by Leaders International.
