To do so, the project will leverage and build on the concept of corporate social responsibility to promote 'Corporate Entrepreneurship Responsibility' by creating an alliance that is focused on a shared commitment to promote the growth of smaller suppliers in underserved, non-central regions of the country.

CERA will facilitate the development of business linkages between beneficiary enterprises and alliance members. At a scale, this approach would redistribute economic growth to other regions in the country, spurring job creation and reducing unemployment as a result.

### Scope of Work:

- Code and customize the portal's content management system and database to host hundreds of open-source tools and resources (backend development).
- Communicate with project's team to design the graphics of portal.
- Design and code the portal's layout/user interface and user experience as required after consulting with the project's team.
- Upload a collection of carefully collected open-source solutions to the website and ensure the user's easy access and utilization of each.
- Develop SEO-friendly content for the portal.
- Run SEO audit, and ensure that portal tags, keywords, and titles for each page/section is provided in the content management system.

- Apply Google Analytics and other analytical tools to be able to monitor and track visitors and subscribers on the portal.
- Ensure the portal's responsiveness to all types of screens (mobile, tablet, desktop).
- Test and troubleshoot the portal and all its applications on various browsers (chrome, internet explorer, etc.).
- Test the portal for bugs, security issues, errors, and user friendliness
