- 4. Training Delivery:
 - Deliver a 2–3-day workshop.
 - Use real-time demonstrations of Microsoft 365 Copilot in Word, Excel, PowerPoint, Outlook, and Teams.
 - Incorporate group work, use-case development, and Q&A sessions.
- 5. Materials, topics & Tools:
 - Topics of training are not limited to; Introductions, uses of copilot in word, excel, PowerPoint, outlook, and teams, integrating copilot with business data and automating workflow.
